(57) Method for the production of flat metal products, in particular coils of strip, in endless and/or semi-endless mode, in which a metal product is continuously fed to a rolling mill consisting overall of at least 4 stands, in which the rolling stands 5 are, in sequence, roughing stands (18a, 18b, 18c), and finishing stands (21a, 21b, 21c, 21d, 21e), wherein it is provided to perform a flying gauge change, namely a change of thickness without interrupting the rolling process, of the metal product exiting from the rolling mill. At least the

rotation speed of the rollers of the first stand (18a) of the rolling mill and their gap are not modified during the flying 10 gauge change of the strip. The transition from the current thickness to the subsequent thickness occurs by applying a new set-up of parameters, for example gap between the rollers, speed of the rollers and inter-stand tension, to all the rolling stands involved in the flying gauge change. The number of stands involved in the flying gauge change, starting from the last stand (21e) of the 15 finishing stands, is obtained taking into account the distribution of the rolling force of each stand, so that the new distribution of forces due to the thickness change does not cause the value of the rolling force of any stand whatsoever to exit from an acceptable tolerance range.
