Kufuatia marekebisho ya kifungu cha 238 cha Sheria ya Kampuni Nam.15 ya mwaka 2013, yaliyofanywa kupitia kifungu nambari 29 cha Sheria ya Fedha namba 3 ya mwaka 2021 ambacho kimefuta usajili wa kampuni zilizoanzishwa Tanzania Bara na kupewa Hati ya kukidhi Matakwa (Certificate of Compliance) na kuweka utaratibu bora wa usajili wa Kampuni za aina hii, kampuni zote zilizoanzishwa Tanzania Bara na kupewa Hati hiyo Zanzibar kabla ya marekebisho haya, zinatakiwa kusajiliwa upya kwa mujibu wa Sheria ya Kampuni ili zipatiwe Hati ya Usajili (Certificate of Incorporation).

Usajili huo mpya ufanyike ndani ya kipindi cha siku tisini (90) kuanzia tarehe ya kutolewa Tangazo hili. Kampuni yoyote itakayoshindwa kufanya hivyo ndani ya muda uliyowekwa itafutwa kwenye Daftari la Usajili na kutapelekea kukosa Sifa ya kufanya shughuli zake Zanzibar.

**PUBLIC NOTICE ON COMPLIANCE TO THE AMENDMENT
OF SECTION 238 OF THE COMPANIES ACT, 2013**

Following the amendment of section 238 of the Companies Act, No. 15 of 2013 by enactment of section 29 of Finance Act, No. 3 of 2021 restraining the issuance of Certificate of Compliance to Tanzania Mainland incorporated Companies, and set a better procedure of incorporating such companies in Zanzibar, All Tanzania Mainland incorporated Companies registered here in Zanzibar under the said section 238 before the amendment, are hereby ordered to re-register for the Certificate of Incorporation in accordance to the provision of the Companies Act.

The re-registration under this Notice shall be made within Ninety days effective from the date of this notice, upon default, the companies will be struck off from the Register.
