## THE ZANZIBAR BUSINESS AND PROPERTY REGISTRATION AGENCY (FEES AND CHARGES) REGULATIONS

[Made under section 24(2)(c)]

L.N 55 of 2025

IN EXERCISE of the power conferred upon me under section 24(2)(c) of the Zanzibar Business and Property Registration Agency Act, No. 13 of 2012, I, OMAR SAID SHAABAN, Minister of Trade and Industrial Development, do hereby make the following Regulations:

#### PART ONE PRELIMINARY PROVISIONS

Short title and commencement. 1. These Regulations may be cited as the Zanzibar Business and Property Registrations Agency (Fees and Charges) Regulations, 2025 and shall come into operation after being signed by the Minister and published in the Gazette.

Interpretation.

- 2. In these Regulations, unless the context otherwise requires:
  - "Act" means the Zanzibar Business and Property Registration Agency Act, No. 13 of 2012;
  - "Agency" has the same meaning as ascribed to it under the Act; and
  - "Registrar" has the same meaning as ascribed to it under the Act;

### PART TWO AGENCY FEES AND CHARGES

Fees and charges.

3.-(1) There shall be fees and charges to be collected by the Agency as prescribed under the First Schedule of these Regulations.



- (2) The fees and charges paid under the provisions of these Regulations shall be non-refundable.
  - 4. Every penalty shall be calculated using cumulative formula.

Penalty with cumulative formula.

## PART THREE MISCELLANEOUS PROVISIONS

- 5.-(1) The Registrar shall charge any person a penalty set out in Powers of these Regulations whenever there is an apparent failure to comply with Registrar. the requirement under the relevant laws.
- (2) The Registrar may, at his absolute discretion, reduce or remit payment of any fee or charge under these Regulations as he may think fit in any particular case.
- (3) The Registrar shall, if exercises the power under subregulation (2) of this regulation, endorse on the application form set out in the Second Schedule of these Regulations, a note of reduction or remission, or otherwise, and of the reasons therefor.
  - **6.-(1)** The following schedules are hereby revoked:

Revocation and saving.

- (a) Schedule 1MM of the Registration of Document Rules of the Registration of Document Decree, Cap. 99;
- (b) First Schedule of the Zanzibar Industrial Property Regulations,
- (c) Second Schedule of the Companies Regulations, 2017,
- (d) The part of "FEES" contained in the Second Schedule of the Registration of Business Names Rules made under the Registration of Business Names Decree, Cap. 168;
- (e) Second Schedule of the Business Entity Registration Regulations, 2018; and
- (f) Third Schedule of the Secured Transaction on Movable Property Regulations, 2018.



(2) Notwithstanding the provisions under subregulation (1) of this regulation, anything done or purported to be done under the revoked regulations shall be deemed to have been done under the provisions of these Regulations.


